#### **About CCD**

CCD is an institution established in 2001 with the main aim of doing research in social sciences on issues of social, cultural and political significance, with particular reference to Gujarat. It is an academic centre meant to harness the knowledge of social sciences to the service of Gujarat society, particularly its disadvantaged sections, and more specifically, minorities, tribals, dalits, and women. The specific focus of CCD is on conflict resolution, the interface between culture and economic development, and social discrimination violating human rights. The Centre's field of activities includes research, evaluation, training, and relevant interventions. It undertakes research projects, and publishes literature with an activist orientation when required.

#### **Infrastructure**

CCD is located on the XTI campus, two kilometers from the periphery of Baroda (now Vadodara) city, in a rural area surrounded by greenery. Vadodara is geographically central in Gujarat, well connected by road, rail and air. The campus is lined by huge trees and is somewhat cooler than the city. CCD is housed in its own building. A new wing with ground floor for library and first floor for conference hall was added last year. The library collection is digitized with more than 4,500 volumes in social sciences, and a large collection of articles and reprints, making a total of about 9,000 entries, and newspaper clippings. The library subscribes to 30 journals. The Centre has a laser printer and a copier, seven computer systems, and a multimedia projector for training courses and workshops. It also has a modest guest house which can accommodate fifteen guests with moderate comforts.

- **II.** Book Launch of: 1. The Structure of Indian Society: Then and Now, by A.M. Shah, Delhi: Routledge, and 2. Malaria in the Social Context: A Study in Western India, by Lancy Lobo, Delhi: Routledge, on July 17, 2010 at CCD. Professor P. J. Patel, former Vice Chancellor of Sardar Patel University, Vallabh Vidyanagar presided over the function and spoke on Professor A. M. Shah's book. Professor Biswaroop Das spoke on Lancy Lobo's book. Ms. Omita Goyal of Routledge, Delhi spoke on the production of both these books.
- III.A panel discussion on Caste and Census was held on September 3, 2010 at CCD. The Panelists were: Professor P. J. Patel, Professor A. M. Shah, and Dr. Arjun Patel.

The Indian government is confronted by a demand for including caste in the decennial census of India. The government has not accepted this demand but agreed to include caste in the BPL census. The panelists discussed various aspects of this issue.

IV. A workshop on "Tribals in Transition" was held on February 16-17, 2011 at CCD. There were 25 participants, with four experts monitoring the workshop. An inaugural address was given by the Bishop of Baroda (Dr. Godfrey De Rosario) followed by an introduction to the workshop by Dr. Lancy Lobo. Professor Biswaroop Das moderated the discussions.

The objectives of this workshop were to discuss: (1) The Changes among tribals and how we view their status; (2) Tribals and us and the evolutionary ladder: Sanskritisation and Christianisation; (3) Culture and Society among tribals, and (4) Redefining our Mission through Relevant Interventions.

The participants made presentations on their experiences and perceptions of tribals in transition.

Lancy Lobo gave an overview of tribals, and clarified and identified issues emerging from the overview.

Jayesh Shah discussed (1) Deprivation of tribals with reference to Land alienation, (2) Forests and tribals.

Professor A.M. Shah spoke on: "Who are the tribals?" and "Should we emphasis tribal culture or tribal society?"

There was discussion on key issues, some policy implications, and action plan.



### Publications Book by Lancy Lobo

Malaria in the Social Context: A Study in Western India. New Delhi: Routledge, 2010.



Maria is a major concern in several parts of Asia, Africa, and Central and South America, with approximately 40 per cent of the world's population at risk of contracting it. The disease has frequently made a comeback in regions where it had almost been eliminated.

This is a path-breaking book in medical anthropology, a field of study which is in its infancy in India. It examines traditional knowledge systems in conjunction with biomedical elements to promote effective health education. An empirical study of malaria in the social context, it explores folk beliefs, attitudes and perceptions affecting various aspects of incidence and treatment of malaria in south Gujarat, in a culturally and socioeconomically stratified population in three ecologically differing rural zones coastal, irrigated plains, and dry highland and one urban site.

Based on intensive fieldwork and extensive surveys, the book brings out the importance of medical pluralism, including the role of indigenous ideas and practices, and analyses the role of private and government appointed doctors at the village level while examining the impact of allopathic medicine.



The book aims to assist health interventionists in spreading efficacious health education and awareness to eradicate malaria. It will be useful for others working in similar fields, to sociologists and social anthropologists, medical scientists, health practitioners, and policy makers, both in the field of malaria eradication and more broadly those working in public health and medicine.

#### **Current Projects**

## 1. Changing Character of Religiosity and Communal Consciousness in Gujarat (1980-2010)

There has been an upsurge in religion, religiosity, and fundamentalism, often leading to fanaticism, manifesting in marked increase in the number of shrines, temples, churches, mosques, gurudwaras, religious activities, programmes, and festivals. A notable increase of



all these is seen especially in Gujarat. With a view to understand this changing situation, this study focuses on social organisation of religion. It is based on an empirical study of shrines in rural and urban sites in Vadodara district.

A schedule was canvassed around each religious shrine at four sites in Vadodara District:

- (I) Amulti-caste, multi-religious village Jabugam (Taluka Jetpur Pavi)
- (ii) A small town Areas under Dabhoi Municipality
- (iii)Two areas of Vadodara Municipal Corporation part of Vadodara (East) and part of Vadodara (West)
- (iv) Photography of each religious shrine, videography of religious celebrations and events, and interviews of religious leaders form part of data collection.

This study is being conducted by Lancy Lobo and Jayesh Shah guided by Professors A. M. Shah and Biswaroop Das. It is supported by a grant from the Indian Council of Social Science Research, New Delhi (Ministry of Human Resource Development).

## 2. The Voting Pattern in Vadodara Rural and Urban Sites in the Local Elections of 2010

Elections of the local self-government bodies provide an idea of the relative strength of individual and group behaviour and modern orientations in politics, which may have long-lasting impact on regional politics. It throws light on the nature, extent and limits of different caste and community voting as well as of individual voting as an effective factor in electoral behaviour. Do primordial ties still influence voting behaviour of the individual voter? To what extent do individuals vote as individuals transcending caste and creed? To what extent has Indian democracy matured as far as electoral behaviour goes? These are some of the questions which we plan to investigate in this study by analysing booth level voting.

The following sites were studied in detail:

- 1. Five election wards (Nos. 5, 6, 7, 17 and 19) comprising part of Vadodara (East) of Vadodara Municipal Corporation (VMC) out of the total 25 election wards in VMC.
- 2. All twelve election wards of Dabhoi Municipality
- 3. All election booths of Jabugam Village (Taluka Jetpur Pavi)
- 4. All election booths of Vadu Village (Taluka Padra)

The study of the 2010 local elections was made by Jayesh Shah and Lancy Lobo. CCD planned to study similarly every election to be held in these study areas.

#### 3. Study of the Journal of the Anthropological Society of Bombay

Prof. A M Shah has undertaken a study of the *Journal of the Anthropological Society of Bombay* established in 1886. The Indian Council of Social Science Research has given to CCD a grant for carrying out this study. The initial work of procuring the issues of the journal is progressing.


