About CCD

CCD is an institution established in 2001 with the main aim of doing research in social sciences on issues of social, cultural and political significance, with particular reference to Gujarat. It is an academic centre meant to harness the knowledge of social sciences to the service of Gujarat society, particularly its disadvantaged sections, and more specifically, minorities, tribals, dalits, and women. The specific focus of CCD is on conflict resolution, the interface between culture and economic development, and social discrimination violating human rights. The Centre's field of activities includes research, evaluation, training, and relevant interventions. It undertakes research projects, and publishes literature with an activist orientation when required.

Infrastructure

CCD is located on the XTI campus, two kilometers from the periphery of Vadodara city, in a rural area surrounded by greenery. Baroda (now Vadodara) is geographically central in Gujarat, well connected by road, rail and air. The campus is lined by huge trees and is somewhat cooler than the city. CCD is housed in its own building. The digitized library houses more than 5000 volumes in social sciences, and a large collection of articles, and reprints, making a total of about 9000, entries and newspaper clippings. The late Professor B.V. Shah's children have donated around 200 books in English and Gujarati to CCD library during this year. The library subscribes to 30 journals. The Centre has a laser printer and copier, seven computer systems, and a multimedia projector for training courses and workshops. It also has a modest guest house which can house fifteen guests with moderate comforts. CCD has a dynamic website: www.ccdgujarat.org.



Book by Lancy Lobo and Jayesh Shah eds., *Globalization, Growth, and Employment: Challenges and Opportunities*, Jaipur: Rawat Publications.



Globalization and subsequent changes are affecting all national economies irrespective of whether it is a transitional, controlled, socialist, or market economy. The result of this change is a paradigm shift in the employment structure of most of the countries. A common trend observed worldwide is that employment is moving away from traditional agriculture to industry and more to services. This volume makes an attempt to evaluate the employment scenario in different sectors of Indian economy after the reforms period. It also makes a comparative study of employment scenario between Gujarat, one of the developed states, and the country as a whole. Employment intensity of economic growth with focus on rural transformation, social security, quality and employability, survival of marginalized labouring poor and social income throws light on the realistic scenario. Retail boom, establishment of SEZs and social security schemes like MGNREGA have suggestive thrusts in the domain of employment and consequences such as migration and their effects on society and culture.

Current Projects

1. Changing Character of Religiosity and Communal Consciousness in Gujarat (1980-2010)

There has been an upsurge in religion, religiosity, and fundamentalism, leading to fanaticism, manifesting in marked increase in the number of shrines, temples, churches, mosques, gurudwaras, religious activities and programmes, and in festivals. A notable increase is seen in religiosity, one-upmanship, nationalism and assertion of ethnic identity in Gujarat. Frequent communal clashes and riots erupt for real or fictitious reasons. This study focuses on social organisation of religion, based on an empirical study of shrines in rural and urban sites in Vadodara district.

A schedule was canvassed around each religious shrines at four sites in Vadodara District:

- (i) A multi-caste, multi-religious village – Jabugam (Taluka Jetpur Pavi)
- A multi-tribal, multi-religious village Vadu (Taluka Padra) (ii)
- A small town Areas under Dabhoi Municipality (iii)
- (iv) Two areas of Vadodara Municipal Corporation – part of Vadodara (East) and part of Vadodara (West)

Photography of each religious shrine, videography of religious celebrations and events, and interviews of religious leaders form part of data collection. This study was conducted by Lancy Lobo and Jayesh Shah guided by Professors A. M. Shah and Biswaroop Das. Also being conceived is an Atlas of Shrines and documentaries on different religious events. This study received financial assistance from the Indian Council of Social Research, Delhi.

2. Booth Level Voting Pattern in Vadodara Rural and Urban Sites in the Taluka Panchayat Elections of 2011

Elections in Gujarat state provide case study of the relative strength of individual and group behaviour and modern orientations in Gujarat politics which may have long-lasting impact on regional politics. More specifically, it can throw light on the nature, extent and limits of different caste and community voting as well as individual voting patterns as an effective factor in electoral behaviour. Do primordial ties still influence voting behaviour of the individual voter? To what extent do individuals vote as individuals transcending caste and creed? To what extent has Indian democracy matured as far as electoral behaviour goes?



These are some of the questions which we would like to investigate in this study by analysing booth level voting.

The following sites were studied in detail:

- (i) Five election wards (Nos. 5, 6, 7, 17 and 19) comprising part of Vadodara (East) of Vadodara Municipal Corporation (VMC) out of the total 25 election wards in VMC.
- (ii) All twelve election wards of Dabhoi Municipality
- (iii) All election booths of Jabugam Village (Taluka Jetpur Pavi)
- (iv) All election booths of Vadu Village (Taluka Padra)

The study of the 2010 local elections was made by Jayesh Shah and Lancy Lobo. It is planned to study elections in these sites over a period of time.

3. Study of the Journal of the Anthropological Society of Bombay

Prof. A M Shah has undertaken a study of the *Journal of the Anthropological Society of Bombay* established in 1886. The Indian Council of Social Science Research has given to CCD a small grant for carrying out this study. The initial work of procuring the issues of the journal is progressing.

4. The study report on Forests and Tribals' Livelihood: Their Changing Character in Gujarat (1947-2007) has been substantially revised and the manuscript has been submitted for publication.


